St Lucia is one of the most developed nations in the Caribbean offering advanced and modern facilities and infrastructure. Established in 2015, St Lucia is now offering high-net worth individuals the opportunity to gain citizenship with more investment options than any other island including donation, real estate, government bond and enterprise investments.

Although the citizenship program is fairly new, St Lucia has become one of the most sought-after passports in the Caribbean. Successful applicants can obtain a passport within as little as 3 months through the streamlined process set by the Citizenship By Investment Board.
